## Alteration of Gateway determination for Camden Local Environmental Plan 2010 (Amendment No. 21) – 190 Raby Road, Gledswood Hills (PP\_2013\_CAMDE\_014\_00)

I refer to Council's request to alter the Gateway determination for PP\_2013\_CAMDE\_014\_00, originally issued on 19 August 2013, by extending the timeframe by 12 months.

I have determined, as delegate of the Greater Sydney Commission, in accordance with section 56(7) of the *Environmental Planning and Assessment Act 1979,* to alter the Gateway determination, dated 19 August 2013 (as altered on 11 January 2017), for the planning proposal PP\_2013\_CAMDE\_014\_00, which seeks to amend the *Camden Local Environmental Plan 2010* and rezoning land at 190 Raby Road, Gledswood Hills from RU2 Rural Landscape, to R1 General Residential, R2 Low Density Residential and R5 Large Lot Residential.

This Gateway determination has been subject to a number of alterations seeking an extension of time and concern is raised regarding the length of time taken to finalise the plan. The Department has limited the extension to 9 months and requests that the Council endeavour to meet the new timeframes. I enclose the Alteration of Gateway Determination for your attention.
