Introduction

The purpose of this planning proposal is to list a steam powered road engine known locally as the 'Fowler Steam Engine' as a heritage item. The engine has been identified as a valuable piece of engineering history, and listing will assist in providing for the on-going protection of the engine as well as recognise its heritage significance.

Background

The Fowler Steam Engine is a steam powered road engine which weighs 20 tonnes and contains 7' diameter rear wheels. The engine has been associated with the Narromine Community since the 1920s when it was imported from England for use by Council. The engine was manufactured at the Steam Plough Works in Leeds England and delivered to Austral Engineering (Australia) on the 1st August 1925. It is likely to be one of the last Fowler Steam Locomotives to be imported into Australia when the firm ceased steam construction (Council Report, Feb 2016).

It believed to have been used primarily for road construction and haulage around the shire until it was retired from Council in February, 1939. Following its retirement the engine was sold to Mr Neil Hamblin of 'Avoca', Tottenham, where it was used for land clearing, driving a chaff-cutter and sinking a large dam until it was made dormant in 1951. The engine was donated back to Council in 1974 by Mr Hamblin. The engine remains substantially intact (see images). There are two badges attached to the engine. One reads the name of its manufacturer and engine number. The other has inscribed the name of its purchaser, which reads TIMBREBONGIE SHIRE COUNCIL, NARROMINE NSW.

A Conservation Management Plan (CMP) was prepared for the engine in 2008. Council resolved to put the plan on public exhibition for 28 days in its April 2008 meeting. Council received considerable feedback from steam enthusiasts in relation to the method, and extent of restoration (Council Minutes, June 2008, p. 9). These submissions were sent to Council's CMP consultant John Gibson for consideration.

As a result of this it was decided that the scope of works in the CMP would be amended to clarify the intent of the proposed restoration works. The recommended restoration works were not to drastically restore the engine and remove the last traces of original paint finished, but rather retain as much of the original finishes as possible whilst returning to some working order deemed most appropriate by Council (Council Report, Oct 2008). Council resolved to adopt the amended conservation management plan and scope of works for the Fowler B6 Steam Locomotive and Traction Wagon, and investigate whether the boiler could be repaired in its October 2008 meeting.

Council resolved to at its meeting on the 10th, February 2016 to undertake the restoration works on the Fowler engine and *That Council list the Fowler Steam Engine as a movable Heritage Item in the Local Environmental Plan* (Council Minutes, Feb 2016).

Part 1

A statement of the objectives or intended outcomes of the proposed instrument.

The objective of this planning proposal is to amend schedule 5 of the Narromine Local Environmental Plan 2011, by adding the Fowler Road Locomotive No. 16163 to protect the local heritage and significance of the item.

Part 2

An explanation of the provisions that are to be included in the proposed instrument.

To achieve the intended outcomes, the planning proposal seeks to amend schedule 5 of Narromine LEP 2011, to include the following under part 1, Heritage Items:

As the engine is an item of movable heritage it is proposed that a listing be placed into the LEP without a fixed location. Council has previously resolved that the engine be transported to the G&C Foundry at Yarrowyck for restoration works. Completing the works may take up to 4 years. Following the restoration Council is to organise a secure facility in which to house and display the engine within the shire. The engine is presently stored at the Narromine Aerodrome. If the engine is restored to operating condition it is proposed that on special occasions the engine be moved to an event location and steamed where it will move under its own power.

Part 3

The justification for those objectives, outcomes and the process for their implementation.

Section A : The Need for the Planning Proposal

1. Is the planning proposal a result of any strategic study or report?

Yes. The item was recommended for local heritage listing by independent heritage adviser to Council, Mr Christo Aitken. A conservation management plan was prepared by independent heritage consultant Heritech Consulting for the restoration and maintenance of the engine. This has been attached to this report. The plan strongly recommended that the engine be listed as an item of local heritage significance.

2. Is the planning proposal the best means of achieving the objectives or intended outcomes, or is there a better way?

Yes. The item satisfies the NSW Heritage Council's Criteria for local heritage significance and listing the engine as a heritage item through the Planning Proposal is the best means of ensuring the conservation of the item.

Section B: Relationship to Strategic Framework

3. Is the planning proposal consistent with the objectives and actions of the applicable sub-regional strategy?

Yes. The amendment is consistent with the Western Regions Sub-Regional land use strategy. Clause 13.3(c) of this strategy states Narromine Actions should include – *Implement the recommendations from the Narromine heritage study through the new LEP by the creation of a heritage schedule that lists heritage items.*

This exhibition will be notified in the local newspapers and on Councils website. Hard copies of the proposal will be available for viewing at Councils Administration office at 124 Dandaloo St in Narromine. The content of the notice will be in accordance with the Department of Planning's Guide to preparing LEPs.
