PLANNING PROPOSAL - 370 OLD NORTHERN ROAD, CASTLE HILL

The Hills Local Environmental Plan 2012 (Amendment No. (#)) – to include a local provision that facilitates an environmentally integrated housing development at 370 Old Northern Road, Castle Hill (8/2016/PLP)

Pursuant to Section 117(2) of the *Environmental Planning and Assessment Act 1979* (EP&A Act), it is advised that Council has resolved to prepare a planning proposal for the above amendment.
