Wollondilly Council has joined forces with Blue Mountains Council to oppose the raising of the Warragamba Dam Wall, and are looking at entering into a formal alliance to protect the indigenous sites as well as the natural environment, plant and animal species that will be impacted by the proposed wall raising. Once we have damaged this heritage it can't be replaced!

Our Council has already stated its opposition to the raising of the dam wall and has been advocating against it for the past 12 months. In July 2018 at our Ordinary Council Meeting, we discussed the potential impacts to indigenous sites and heritage in the Burragorang Valley. Last year Council invited a Gundungurra representative to make a presentation at a special Community Forum. Earlier this year we hosted two well-attended screenings of the 'Give a Dam' documentary at Picton and Warragamba.

The issue has recently gained international attention with UNESCO's World Heritage Committee finding the proposal to raise the dam wall by 14m incompatible with the world heritage status of our iconic Blue Mountains. UNESCO has called on the Australian Government to let it review the project's environmental impact statement before any final decisions are made.

Therefore, I would like to put forward the following recommendations:

Recommendations:

- That the Council notes the UNESCO World Heritage Committee's concerns about the proposed raising of the Warragamba Dam and the associated frequency and extent of flooding within the boundary of world heritage property, which is likely to have an impact on its outstanding universal value, and UNESCO's World Heritage Committee's resolution that prior to any decision being made regarding the dam, the Australian Government prepare an Environmental Impact Statement, to be submitted to the Committee by December of next year for its consideration at its 2021 meeting.
- 2. That the Council seeks to formalise an alliance with Blue Mountains, Hawkesbury, Penrith, , Liverpool, Camden, Lithgow, Oberon and Wingecarribee City Councils to jointly advocate our concerns and opposition to the raising of the Warragamba Dam; and
- 3. That the Council agrees to organise a public forum on the raising of the Warragamba Dam and to provide supporting media promotion of the issues.

During May 2019 Council received 2 applications for a Donation and 1 request for Sponsorship:

- \$250 donation for Mali Dillon towards attending the NSW Youth Council Conference as a youth representative of the Wollondilly Region.
- \$1,000 sponsorship for the Camden / Wollondilly Domestic Violence Committee for their 2019 White Ribbon Day Breakfast.
- \$500 donation for Cawdor School P&C Association towards the purchase and installation of an Honour Board to recognise student Academic and Citizenship Outcomes.

These requests have been assessed against the Financial Assistance Program criteria and deemed eligible to receive funding through the Donation and Sponsorship Programs.
