I am writing in response to correspondence from Edward River Council (Council) dated 28 October 2016 requesting an Alteration of Gateway determination to identify the correct gun that Council is seeking to list as a moveable heritage item in Schedule 5 of the *Deniliquin Local Environmental Plan 2013*.

I understand that the correct gun that Council is seeking to list is the 12 Pounder Rifled Breech-Loading Gun (Armstrong) located at Lot 11 DP 544836, 72-96 End Street, Deniliquin as the moveable heritage item. Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2016_ERIVE_001_00)

I, Acting Director Regions, Western at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* to alter the Gateway determination dated 5 October 2016 for the proposed amendment to the *Deniliquin Local Environmental Plan 2013* as follows:

1. Change the name and description of the Planning Proposal

from "to identify a 75MM Field Gun as a moveable heritage item"

to "to identify a 12 Pounder Rifled Breech-Loading Gun (Armstrong) located at Lot 11 DP 544836, 72-96 End Street, Deniliquin as a moveable heritage item in the Deniliquin Local Environmental Plan 2013"
