TAMWORTH REGIONAL LOCAL ENVIRONMENTAL PLAN 2010 SUBMISSION OF THE PLANNING PROPOSAL FOR THE TAMWORTH ENTERPRISE AREA, WESTDALE

The purpose of this letter is to submit the *Tamworth Enterprise Area Planning Proposal* to the Department of Planning and Environment in accordance with Section 56 of the *Environmental Planning and Assessment Act 1979*. Council at its meeting on 22 August 2017 resolved to forward the planning proposal to the Minister for Planning and Environment seeking a Gateway Determination. Please see Council Report attached.

The objective of this proposal is to facilitate the development of employment generating and business activity lands on a significant area of land located approximately seven (7) kilometres to the west of Tamworth City. The subject lands are referred to as the Tamworth Enterprise Area in this planning proposal. The proposed amendment aims to amend the *Tamworth Regional Local Environmental Plan 2010 (TRLEP 2010) Land Zoning Map and Lot Size Map.*

The subject lands are identified as Lot 2 in DP 816346 and Lot 462 in DP 1178998, Westdale which is a suburb of Tamworth City, NSW. In total approximately 246 hectares are affected by the proposed amendments. The proposal is in accordance with the *New England North West Regional Plan 2036* which was approved by the Department on 23 August 2017 and identifies the subject lands as 'Enterprise Investigation Area' on page 31.

Council has undertaken over twelve (12) months of investigation in the subject lands in relation to flora & fauna, heritage, traffic, drainage, contamination and servicing of the site. The planning proposal has been prepared by Tamworth Regional Council in accordance with *Section 55* of the *Environmental Planning and Assessment Act 1979* and the Department of Planning Guidelines, 'A guide to preparing Local Environmental Plans' and 'A guide to preparing Planning Proposals'.

Council would like to confirm its request to exercise plan making delegations in respect to this planning proposal. Please see attached a copy of the *Evaluation Criteria for the Delegation of Plan Making Functions* and a copy of the *Delegated Plan Making Reporting Template*.
