Planning Proposal to rezone part of 528 Caniaba Road, Caniaba

At its Ordinary Meeting held on 8 October 2019, Lismore City Council considered a Planning Proposal to amend the Lismore LEP 2012 to rezone part of 528 Caniaba Road, Caniaba to enable large lot residential development and protect the identified ecological values on the site.

The Council resolution is that:

- 1. Council support the planning proposal included at Attachment 1 of this report that proposes an amendment to the Lismore Local Environmental Plan (LEP) 2012 to rezone part of the land at 528 Caniaba Road, Caniaba to enable large lot residential subdivision and protect identified ecological values of the site.
- 2. The proponent provide:
 - > a contaminated land assessment
- 3. The proponent is to prepare a Structure Plan in consultation with Council to guide the future development of the site, for inclusion in Chapter 6 of the Lismore Development Control Plan, prior to the making of this LEP amendment.
- 4. Council forward the planning proposal to the NSW Department of Planning, Industry and Environment (DPIE) and request a Gateway Determination.
- 5. Council agree that staff can proceed to public exhibition of the planning proposal and government agency consultation based on the Gateway Determination and report back to Council with any issues as part of post-exhibition reporting of submissions.
