## RE: REQUEST FOR GATEWAY DETERMINATION – PENNY LANE LAND ACQUISITION RELEASE PLANNING PROPOSAL

The purpose of this letter is to seek a Gateway Determination in relation to a Planning Proposal for Thirlmere Car Park, Penny Lane Land Acquisition.

At its Ordinary Council Meeting held on Monday 15 June 2015, Wollondilly Shire Council resolved as follows:

- 1. That Council prepare a planning proposal to release Lots B & C DP 383947 and Lot 3 Section C DP 1569 from the land reserved for acquisition in Wollondilly Local Environmental Plan, 2011.
- 2. That the Planning Proposal be forwarded to the Minister for Planning and Environment for a Gateway Determination.
- 3. That Council request the Minister to grant Council delegation to make the amendments to Wollondilly Local Environmental Plan, 2011 in accordance with Section 59 to the Environmental Planning and Assessment Act, 1979.
- 4. That a further report be provided to Council detailing the requirements of any Gateway Determination and give consideration to whether the Planning Proposal should proceed.

Subsequently, we now request the Minister for Planning & Environment determine that the planning proposal should proceed and issue a Gateway Determination on the Planning Proposal in accordance with section 56 of the *Environmental Planning and Assessment Act 1979* (EP&A Act).

We are also seeking delegation to carry out the plan making functions as this the planning proposal relates to a matter of local significance.
