Alteration of Gateway Determination

Planning Proposal (Department Ref:) PP_2016_AREGI_002_00

1, the Executive Director, Regions at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the Environmental Planning and Assessment Act 1979 (the Act) to alter the Gateway Determination, dated 17 December 2016, for the proposed amendment to the Armidale Dumaresq Local Environmental Plan 2012 as follows:

1. Delete paragraph 1

"I, the Acting Director, Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 (the Act) that an amendment to the Armidale Dumaresq Local Environmental Plan (LEP) (2012) to remove Lot 54 DP 596242 from Item No I067 in Schedule 5 -Environmental Heritage should proceed subject to the following conditions:"

and replace with a new paragraph 1

"I, the Executive Director, Regions at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 (the Act) that an amendment to the Armidale Dumaresq Local Environmental Plan (LEP) (2012) to remove Lot 54 DP 596242 from Item No I067 in Schedule 5 -Environmental Heritage should not proceed."

2. Delete conditions 1 to 4.
