

Gateway Determination

Planning proposal (Department Ref: PP_2017_BLACK_002_00): to amend Blacktown Local Environmental Plan 2015 to rezone and increase the height of buildings of land within the subject site of Old Mount Druitt Village.

I, the Director, Sydney Region West, Planning Services at the Department of Planning and Environment, as delegate of the Greater Sydney Commission, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act), that the proposal should proceed subject to the following conditions:

- 1. Prior to community consultation, the planning proposal must be updated to address the Draft West Central District Plan.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of the Department's 'A Guide to Preparing Local Environmental Plans'.
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the Act:
 - Transport for NSW Roads and Maritime Services
 - Endeavour Energy
 - Sydney Water Office of Water

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the amending Local Environmental Plan is to be 6 months from the week following the date of the Gateway determination.
