# Planning Proposal to include Middle Harbour Road, Lindfield Heritage Conservation Area in the Ku-ring-gai Local Environmental Plan 2015 (PP\_2016\_KURIN\_007\_00)

I refer to the planning proposal prepared by Ku-ring-gai Council to include the Middle Harbour Road, Lindfield Heritage Conservation Area in the Ku-ring-gai Local Environmental Plan 2015. The planning proposal was placed on public exhibition in accordance with the Gateway Determination between 2 June 2017 and 7 July 2017.

# Council Report and Resolution 24 October 2017

On 24 October 2017 Council considered a report on the submissions received during the public exhibition of the planning proposal. The report recommended that the boundary for the Middle Harbour Road Heritage Conservation Area be revised and encompass a smaller area (refer to revised maps in planning proposal). Assessment of submissions, field work by Council staff, and reviewing historic documents have highlighted that parts of the exhibited conservation area can no longer be considered significantly intact, as contributory buildings in these streets are in the minority. The revised smaller area has clusters of contributory buildings, particularly on Middle Harbour Road, that appear in continuous rows with few non-contributing intrusions. The area also includes every heritage item located within the exhibited conservation area boundary, with exception of one. The contributory buildings and elements represent the majority of the revised conservation area.

Following consideration of the report, Council resolved:

- A. That Council resolves to adopt the Planning Proposal to list the amended Middle Harbour Road Conservation Area as identified in Attachment A4 in Schedule 5 and the Heritage Map of the Ku-ring-gai Local Environmental Plan 2015.
- B. That Council forwards the amended Planning Proposal to the Department of Planning and Environment in accordance with section 59 of the *Environmental Planning and Assessment Act 1979* with a request to make arrangements to give effect to the final proposal.
- C. That those who made a submission be notified of Council's resolution.
