**Various Planning Proposals – Alteration of Gateway determinations**

## Alteration of Gateway Determination

### *Planning Proposal (Department Ref: PP\_2016\_PARRA\_012\_00)*

I, the Executive Director Regions, Planning Services, as delegate of the Greater Sydney Commission, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 17 June 2016 for the proposed amendment to the *Parramatta Local Environmental Plan 2011* as follows:

1. Delete:

condition 6

and replace with:

a new condition 6

"The planning proposal, with any supporting material, is to be forwarded to public authorities for consultation and given at least 28 days to comment on the proposal, together with a covering letter to indicate that the following six planning proposals were issued with a Gateway determination on the same day and will be forwarded for comment individually, although any cumulative implications should be taken into consideration:

- 48 Macquarie Street and 220-230 Church Street, Parramatta (PP\_2016\_PARRA\_004\_00);
- 122 Wigram Street, Harris Park (PP\_2016\_PARRA\_006\_00);
- 14-20 Parkes Street, Harris Park (PP\_2016\_PARRA\_007\_00);
- 2-10 Phillip Street, Parramatta (PP\_2016\_PARRA\_010\_00); and
- 180 George Street, Parramatta (PP\_2016\_PARRA\_016\_00).
