Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2017_PENRI_004_00)

I, the Director, Sydney Region West at the Department of Planning and Environment, as delegate of the Greater Sydny Commission, have determined under section 3.34(7) of the *Environmental Planning and Assessment Act 1979* to alter the Gateway determination dated 9 February 2018 for the proposed amendment to the Penrith Local Environmental Plan 2010, as follows:

1. In condition 1, under *Part 3 – Justificaton*: remove condition 'k)' and replace with the following:

n) Council is to address the consistency of the proposal with the Greater Sydney Region Plan (March 2018) and the Western City District Plan (March 2018).

2. Follwing the removal of condition 'k)' and insertion of condition 'n)', insert after 'j)' in condition 1, the following:

k) By diagrams include under item 4, proposed amendments to the boundaries of the zone and height of building maps, with an explanation and amend the heading of item 4 accordingly.

I) By diagrams include under item 5, proposed amendments to the boundaries of the zone and lot size maps with an explanation and amend the heading of item 5 accordingly.

m) Under item 5, label the site at 4 Baden Powell Avenue, Kingswood (Lot 69 DP 752022) on the land zoning map for identification purposes.
