SUBMISSION OF PLANNING PROPOSAL FOR GATEWAY DETERMINATION 168 NORTON STREET, LEICHHARDT

At its Council meeting on 28 February 2017 Inner West Council considered a Planning Proposal for 168 Norton Street, Leichhardt and resolved to forward the Planning Proposal to the Minister for Planning for a Gateway Determination (refer to Attachment 1 Resolution **C0217 Item3**)

The Planning Proposal seeks to facilitate redevelopment of the site at 168 Norton Street for the purpose of self-contained seniors housing and mixed use development by amending the *Leichhardt Local Environmental Plan* (LEP 2013) as follows:

- include an Additional Local Provisions clause '6.18 Development of land at 168 Norton Street' in Part 6 of the LEP as follows:
 - o an increase of the maximum floor space ratio (FSR) from 1.5:1 to 3:1;
 - limits the increased FSR to a 'seniors housing' development with a minimum of 15% of the dwellings to be 'affordable places' under the definitions contained in *State Environmental Planning Policy (Housing for Seniors or People with a disability) 2004;*
 - o requires an active street frontage along Norton Street.
- amend the Key Sites map to include the site and the application of the new 'Additional Local Provisions' at 168 Norton Street.
