Dear Mr Swift-McNair

Planning proposal to amend Port Macquarie - Hastings Local Environmental Plan 2011

I am writing in response to your Council's letter dated 24 February 2017 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 (the Act) in respect of the planning proposal to rezone land at Homedale Road, Kew from RU1 Primary Production to R1 General Residential, E2 Environmental Conservation and E3 Environmental Management and amend associated development standards.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the planning proposal's inconsistencies with S117 Directions 1.2 Rural Zones, 1.5 Rural Lands and 3.1 Residential Zones and 4.3 Flood Prone Land are of minor significance.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of relevant S117 Directions such as Direction 2.3 Heritage Conservation and Direction 4.4 Planning for Bushfire Protection. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2017_PORTM_002_00): to rezone land at Homedale Road, Kew from RU1 Primary Production to R1 General Residential, E2 Environmental Conservation and E3 Environmental Management and amend associated development standards.

I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Port Macquarie - Hastings Local Environmental Plan (LEP) 2011 to rezone land at Homedale Road, Kew from RU1 Primary Production to R1 General Residential, E2 Environmental Conservation and E3 Environmental Management and amend associated development standards should proceed subject to the following conditions:

1. Prior to community consultation the following site investigations are to be undertaken and placed on public exhibition with the planning proposal:
 - (a) noise assessment report addressing traffic noise from Kendall Rd and the adjacent rural industry; and
 - (b) bushfire assessment
2. Prior to community consultation the planning proposal is to be amended as follows:
 - (a) to incorporate any necessary changes to the proposal arising from the additional site investigations or consultation with State agencies or organisations.
3. Consultation is required with the following public authorities prior to community consultation under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:
 - NSW Rural Fire Service;
 - NSW Department of Industries – Agriculture;
 - NSW Office of Environment and Heritage;
 - Roads and Maritime Services;
 - NSW Aboriginal Land Council;
 - Local Aboriginal Land Council; and
 - Department of Industry - Lands.

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

4. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning and Environment 2016)*.
5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
6. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
