## ALTERATION OF GATEWAY DETERMINATION FOR PLANNING PROPOSAL PP 2015 LISMO 007 00

#### **PURPOSE**

To recommend the Acting Director Regions, Northern as delegate for the Minister agrees to alter the Gateway determination for Planning Proposal no. PP 2015 LISMO 007 00 to rezone land at Goonellabah and Lagoon Grass for residential and environmental management purposes and issue an Alteration of Gateway Determination.

#### RECOMMENDATION

- It is recommended that the Minister's delegate:
  - agrees under s56(7) of the Environmental Planning and Assessment Act 1979 to alter the Gateway determination for Planning Proposal no. PP 2015 2015 LISMO 007 00 in accordance with the Alteration of Gateway Determination document at (Tab A), which in summary involves extending the timeframe for completion by twelve (12) months;
  - agrees that the community consultation requirements in condition 5 of the Gateway determination (which have not yet been met) are sufficient and that no further or different community consultation is required;
  - signs the Alteration of Gateway Determination (Tab A); and
  - signs the letter to Lismore City Council (Tab B).

#### **CURRENT POSITION**

- Council has prepared a Planning Proposal to rezone land at Goonellabah and Lagoon Grass for residential and environmental management purposes and to apply alternative minimum lot sizes and maximum building height controls.
- The Gateway determination issued on 9 December 2015 (Tab C) determined that the proposal should proceed subject to conditions.
- The Gateway determination required that the Local Environmental Plan be finalised in 18 months from the week following the date of the Gateway determination expiring on 9 June 2017.
- Council has requested that the period to complete the proposal be extended for a further 12 months due to delays associated with additional studies to support a concurrent application for biodiversity certification. This is considered appropriate.
- Community consultation in relation to the Planning Proposal in accordance with condition 5 of the Gateway determination has not yet occurred. It is considered that the community consultation that will take place under condition 5 of the Gateway determination is sufficient and that no further or different community consultation is required.

# **Alteration of Gateway Determination**

Planning proposal (Department Ref: PP\_2015\_LISMO\_007\_00)

I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 9 December 2015 for the proposed amendment to the Lismore Local Environmental Plan 2012 as follows:

# 1. Delete:

condition 7 "The timeframe for completing the LEP is to be **18 months** from the week following the date of the Gateway determination"

and replace with:

a new condition 7 "The timeframe for completing the LEP is by 16 June 2018."
