## Planning Proposal – Dunbar Estate in Marsfield

Community members and residents of the Dunbar Estate in Marsfield have requested that Council consider the zoning of the land indicating that its current zoning was not consistent with the current and appropriate future land uses in the neighbourhood and its surrounds.

To address this inconsistency, Council at its meeting of 22 August 2017 resolved the following:

That Council prepare and submit to the NSW Department of Planning and Environment for Gateway Determination, a Planning Proposal for the "Dunbar Park Estate R3 Zone" in Marsfield.

The effect of the Planning Proposal is to amend Ryde Local Environmental Plan 2014 to rezone the land from R3 Medium Density Residential to R2 Low Density Residential in order to harmonise zonings in this area and ensure its character and amenity is maintained.

Accordingly, Council has prepared a Planning Proposal, I am writing to formerly request that the Department of Planning and Environment (DPE) review the Planning Proposal (ATTACHED) and issue a Gateway Determination under Section 56 of the *Environmental Planning and Assessment Act (1979)*.
