REQUEST FOR GATEWAY DETERMINATION - PLANNING PROPOSAL AT NO. 11 WESTMINSTER PLACE, RAZORBACK

Council has resolved to support the preparation of a Planning Proposal to enable the subdivision of Lot 6 DP 1128635 (No. 11) Westminster Place, Razorback.

At its ordinary meeting held on 16 April, 2018, Council resolved the following:

- "1. That Council support the preparation of a Planning Proposal for land being Lot 6 DP 1128635 (No. 11) Westminster Place, Razorback to amend Wollondilly Local Environmental Plan 2011 by one of the following:
 - Amend the original holdings maps to exclude the subject land; or
 - Amend schedule 1 'additional permitted uses' of the LEP to enable the subdivision of land into five (5) lots.
- 2. That the Planning Proposal be forwarded to the Greater Sydney Commission for a Gateway Determination.
- 3. That Council request the Greater Sydney Commission to grant Council delegation to make the amendments to Wollondilly Local Environmental Plan, 2011 in accordance with Section 59 of the Environmental Planning and Assessment Act, 1979.
- That the proponent and submitters be notified of Council's Resolution." 4.

In accordance with the above resolution, Council requests the Greater Sydney Commission to grant delegation to make this amendment to Wollondilly Local Environmental Plan 2011 (WLEP 2011) in accordance with part 3.36 of the Environmental Planning and Assessment Act. 1979.
