Re: Planning Proposal 1/2017 to amend the Narrabri Local Environmental Plan 2012.

I am writing to request a Gateway Determination in relation to the above matter.

At its March Meeting, Council resolved to adopt the above planning proposal and submit it to the Department of Planning and Environment for Gateway Determination. - Lots 218 and 219 DP 755475, 'Hillview' 14019 Kamilaroi Highway Boggabri

Rezone the following land from IN1 General Industrial to RU1 Primary Production to permit rural land uses and establish a corresponding Minimum Lot Size of AB2 (40ha) for each allotment.

- Lot 7004 DP 1028500, 14 Caloola Road Boggabri
- Lot 1 DP 578315 and Lot 1 DP 908028, 'Harvenvale' 51 Vine Lane Boggabri
