### Planning proposal to amend Tamworth Regional Local Environmental Plan 2010

I am writing in response to your Council's letter dated 25 August 2016 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) to rezone land in the Werris Creek Rd, Bylong Rd, Warwick Rd and Burgmanns Lane area of Tamworth for residential and neighbourhood commercial uses and amend associated planning controls.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the planning proposal's inconsistencies with S117 Directions 1.2 Rural Zones, 1.5 Rural Lands, 3.2 Caravan Parks and Manufactured Home Estates and 3.4 Integrated Land Use and Transport are of minor significance. No further approval is required in relation to these Directions.

Due to unresolved issues associated with the quantity of land to be zoned for commercial purposes, and potential environmental, Aboriginal cultural heritage and flooding issues, Council will still need to obtain the agreement of the Department's Secretary to comply with the requirements of S117 Directions 1.1 Business and Industrial Zones, 2.1 Environment Protection Zones, 2.3 Heritage Conservation and 4.3 Flood Prone Land. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

# **Gateway Determination**

**Planning proposal (Department Ref: PP\_2016\_TAMWO\_002\_00)**: to rezone land in the Werris Creek Rd, Bylong Rd, Warwick Rd and Burgmanns Lane area of Tamworth for residential and neighbourhood commercial uses and amend associated planning controls.

I, the Executive Director, Regions at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Tamworth Regional Local Environmental Plan (LEP) 2010 to rezone land in the Werris Creek Rd, Bylong Rd, Warwick Rd and Burgmanns Lane area of Tamworth for residential and neighbourhood commercial uses and amend associated planning controls should proceed subject to the following conditions:

- 1. The area to be zoned B1 Neighbourhood Centre is to be reduced in size to a level more appropriate for the local convenience needs of the residents of the release area. The planning proposal is to be amended and updated, including the strategic justification for the commercial rezoning, and resubmitted to the Department of Planning and Environment for approval prior to undertaking community or agency consultation.
- 2. Prior to community or agency consultation, the planning proposal is to be amended to:
  - (a) identify and map the land as an urban release area for the purposes of Part 6 of Tamworth LEP 2010;
  - (b) remove any references to the draft New England North West Regional Growth Plan;
  - (c) include existing zoning, minimum lot size and floor space ratio maps and the proposed flood prone land map of the subject land; and
  - (d) update the strategic justification to include a discussion on the rezoning of the existing R5 Large Lot Residential area along Bylong and Warwick Roads which are located outside the South Tamworth Rural Lands Masterplan area.
- 3. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
  - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Infrastructure 2016).

- Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:
  - Office of Environment and Heritage
  - NSW Department of Primary Industries Agriculture
  - NSW Office of Water
  - Transport for NSW
  - Roads and Maritime Services
  - Transgrid
  - Essential Energy
  - Tamworth Local Aboriginal Land Council
  - NSW Aboriginal Land Council
  - North West Local Land Services

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal. The agency consultation process is to be completed prior to the commencement of community consultation.

- 5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 6. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
