The process for Amendment to the Local Environmental Plan (LEP) is as follows:

- a). Council resolve to undertake a change to the LEP finalised December 2015.
- b). Council adopt Planning Proposal for Gateway Determination with the
- c). Department Of Planning March 2016.
- d). Planning Proposal assessed for Gateway Determination by the Department
- e). under Delegation in the Dubbo branch. Expected late April 2016
- f). Proposal will be required to be publically exhibited for 14 days May 2016
- g). Submissions received on the proposal must be presented to Council for consideration –May/ June 2016
- h). Proposal to go to Parliamentary Counsel for review.

Council to adopt the final plan and direct General Manager to make the plan in accordance with the Section 59 Report.

Amendment is gazetted and adopted into the LEP.
