RECOMMENDATION: that a Planning Proposal, to be prepared at the proponent's cost, be submitted to the NSW Department of Planning and Environment for a Gateway Determination to amend *Berrigan Local Environmental Plan 2013* to include <u>Backpackers' Accommodation</u> as Permitted with Consent within the RU1 Primary Production Zone.

Items requiring Council Resolution

REPORT:

The need for a planning proposal has arisen to assist rural landowners with the employment of temporary/casual workers during busy seasons, such as harvest. In particular, a local farmer has requested Council to investigate accommodation options for the seasonal workers. Currently, the RU1 Primary Production Zone of the *Berrigan Local Environmental Plan 2013* prohibits Backpackers' Accommodation.

One of the main objectives of the RU1 Primary Production Zone of the Berrigan Local Environmental Plan 2013 is 'to permit development that enhances the agricultural and horticultural production potential of land in the locality'. The inclusion of Backpacker's Accommodation as a permitted use will not only agricultural and horticultural production, enhance but also provide accommodation which is in close proximity to the location of the production. This will assist backpackers from unnecessarily having to drive each day to and from the place of employment. This amendment will also allow rural landholders to entice backpackers to come and work for them, by including accommodation as part of backpacker's remuneration.

In this particular example, it is recommended that a planning proposal be prepared by a Planning Consultant at the cost of the proponent. Despite the fact that there is an obvious benefit to future developers given that the amendment will benefit all landholders in the RU1 Primary Production Zone, the cost should be borne by the proponent given the immediate benefit to him. The Berrigan Shire is proposed to incur the other costs, such as the administration, advertising and exhibition costs with the amendment.

It must also be noted that should the amendment be gazetted, the proponent would still need to submit a development application to gain consent for any development of this nature.

It is considered that the inclusion of <u>Backpacker's Accommodation</u> as a permitted use within the RU1 Primary Production Zone of the *Berrigan Local Environmental Plan 2013* for the reasons listed above should be supported.
