# Summary

Wentworth Shire Council, at its meeting held 19 April 2017, resolved to seek an Opinion for Planning Proposal Amendment 8 from Parliamentary Counsel and submit the amendment to the Department of Planning and Environment (the Department) for finalisation and notification.

The author of that report has just been advised that the owner of one property that was excluded from and recommended to be included in Schedule 5 Environmental Heritage list and the heritage mapping, has applied to demolish the existing building and construct a new dwelling in its place.

Therefore, this report is a repetition of the report to Council two weeks ago but also includes addressing that particular property and its heritage significance.

#### Recommendation

That Council seeks an Opinion for Planning Proposal Amendment 8 from Parliamentary Counsel.

That Council submits the Planning Proposal Amendment 8, including the Parliamentary Counsel Opinion, to the Department of Planning and Environment for finalisation and notification of the amendment to the Wentworth Local Environmental Plan 2011, in accordance with Section 59 of the Environmental Planning and Assessment Act 1979.

# **Detailed Report**

# Purpose

The purpose of this report is to seek Council approval to progress to the final stage of the amendment process by submitting Planning Proposal Amendment 8 to Parliamentary Counsel for an Opinion, then to the Minister of the Department of Planning and Environment for finalisation and notification of the amendment on the legislative website.

# Background

A desk top review of the Wentworth LEP 2011 Schedule 5 Environmental Heritage list identified twenty-one list errors and four mapping errors.

Consultation with Council's former Heritage Advisor also revealed that one commercial building had been erroneously omitted from the list and one dwelling had been renovated and another significantly fire damaged, and their significant heritage features no longer existed.

All of these errors were detailed in the planning proposal report submitted to the Department for consideration of a gateway determination.

# Matters under consideration

The Gateway Determination that was issued by the Department conditioned that Council undertake community consultation for 28 days in accordance with sections 56 (2)(c) and 57 of the Environmental Planning and Assessment Act 1979.

Consultation was conducted for 28 days between 22 July 2016 and 19 August 2016. At the close of the consultation period, Council had received no community submissions to the proposal.

The Gateway Determination also required consultation with the Office of Environment and Heritage (OEH) in accordance with section 56 (2)(d) of the Environmental Planning and Assessment Act 1979.

Council, therefore, notified OEH in writing of the proposal and provided them with 21 days to respond to that notification.

The response to this notification was supplied by the Heritage Council of New South Wales, which raised no objections to the proposal to rectify errors in Schedule 5 or the heritage mapping and supported the inclusion of the additional item to the list.

The response to the removal of two items was to advise Council that the decision to remove these should be on the basis of an assessment of the heritage significance of those items.

# Refer to Attachment 1.

The proposal to remove both of these items from the list and associated mapping is based on an inspection and assessment undertaken by Council's former heritage advisor. The decision to remove both of the items was formed on the advice that one building had been destroyed by fire and the other building had been significantly renovated and modified which had compromised and removed the significant heritage features of that building. Therefore, the advice provided by the Heritage Council NSW has been satisfied.

All conditions of the Gateway Determination dated 2 June 2016 have been satisfactorily completed.

A change has been made to Schedule 5 Environmental Heritage list following the advice received from the NSW Heritage Council regarding the level of significance of the Old Wentworth Gaol.

This item, number I50 in Schedule 5 Environmental Heritage list, is now included on the State Heritage Register, therefore the WLEP 2011 heritage list needs to be altered to reflect the Gaol's level of significance.

The site is owned by Crown Lands with Wentworth Shire Council as the Trustee. Therefore, the change to the significance listing will not have any negative impact on the owner or user of the site.

In addition to the above, the original Heritage List of Amendments endorsed by Council at its meeting held 18 March 2015 included that 35 Cadell Street, Wentworth had been incorrectly included in Schedule 5 Environmental Heritage List, as well as the heritage mapping being incorrectly applied to this address. The listing and mapping was to have been applied to 47 Cadell Street, Wentworth.

The property owner of 47 Cadell Street, Wentworth at that time had not objected to the proposal, but did request that an inspection of the building take place.

The inspection revealed that building itself is structurally unsound and had been modified significantly both internally and externally in an attempt to resolve the lack of structural integrity of the building. These measures have been conducted over the years with no long term success.

The Wentworth Shire Heritage Study listed this property as Item 36 and the significance of the building included:

A single storey small brick cottage with low hipped roof and front verandah supported by iron columns. This early building is constructed with brick stock made in Wentworth. The wooden window cases are surrounded by arch vertical joints. Two slender brick chimneys with external vertical reliefs from the rear of the building. A new extension has been built onto the rear and the verandah has been renovated. The dwelling is in original form, excluding the rear extension and renovated verandah.

An inspection of the building conducted by Health and Planning Officers revealed the following issues and modifications:

- The bricks were eroding and causing significant movement of the external walls
- The wooden windows have been replaced with aluminium windows and the arch vertical joints had been compromised
- Both internally and externally it appeared as though the front verandah and rear extension were responsible for the building still standing
- The front façade had been partially rendered in an attempt to stabilise the movement of the wall.

Although it was evident that the dwelling was all but inhabitable, at that stage it was decided to proceed with the property included in the heritage list and mapping.

However, the property has now changed hands and Council has received an application from the new landowner to demolish the existing dwelling.

Therefore there seems no logical reason to include this property in Schedule 5 Environmental heritage list or the heritage mapping on the basis that the building is structurally unsound, inhabitable and the new owner has now sought to demolish it to be replaced with a new dwelling.

A full list of the amendments to be made to the Wentworth LEP 2011 can be viewed in Attachment 3.

# **Options**

Based on the information contained in this report, the options available to address this matter are to:

- Seek an opinion for the Planning Proposal Amendment No 8 from Parliamentary Counsel, and
- Submit Planning Proposal Amendment No 8 to the Department of Planning and Environment for finalisation and notification.

RE: Planning proposal to amend the Wentworth Local Environmental Plan (WLEP) 2011.

Thank you for your letter dated 11 October, 2016 regarding the abovementioned planning proposal, requesting comments from the Heritage Council.

The planning proposal seeks to:

- Rectify minor descriptive errors in Schedule 5,
- Rectify minor mapping errors.
- Inclusion of one (1) heritage item of local significance which was erroneously omitted from the environmental heritage list at the time of the conversion of the new standard instrument, and
- Removal of two (2) heritage items of local significance from Schedule 5 of the LEP, due to loss from fire and extensive renovations.

The Heritage Division raises no objection to the rectification of errors and updating of existing details and descriptions within the Schedule 5 and/or Heritage Maps of the Wentworth LEP 2011. It is considered that the inclusion of an additional item of heritage significance, will assist in providing a link between past, present and future generations and provide statutory protection to assist with conservation and management of significant places. The Heritage Council of NSW supports the listing of items of local heritage significance where they are supported by a robust heritage assessment.

The planning proposal also aims to remove two (2) items from Schedule 5 - Environmental Heritage list and associate mapping. The removal of one of the items is due to severe fire damage that left the dwelling completely gutted including damage to the structural integrity of the internal brick walls as a result of the heat of the fire. It is noted that Development Approval has already been issued for the demolition of the dwelling on the basis of the advice provided by the heritage advisor. The Heritage advisor has recommended the remaining item to be removed because of the modifications made to this dwelling which have compromised most of its heritage values.

The Heritage Council considers that Council's decision on whether to list or delist a local heritage item in Schedule 5 of the Wentworth LEP should be based on the assessment of the heritage significance of that item in the heritage study or review.





# Summary

Wentworth Shire Council, at its meeting held 18 March 2015, resolved to prepare and submit a Planning Proposal to the Department of Planning and Environment (the Department) for consideration of a Gateway Determination to rectify errors contained within Schedule 5 Environmental Heritage list and heritage mapping of the Wentworth Local Environmental Plan (LEP) 2011.

A Gateway Determination to proceed with the planning proposal was issued by the Department on 2 June 2016.

# Recommendation

That Council seeks an Opinion for Planning Proposal Amendment 8 from Parliamentary Counsel.

That Council submits the Planning Proposal Amendment 8, including the Parliamentary Counsel Opinion, to the Department of Planning and Environment for finalisation and notification of the amendment to the Wentworth Local Environmental Plan 2011, in accordance with Section 59 of the Environmental Planning and Assessment Act 1979.

# **Detailed Report**

# Purpose

The purpose of this report is to seek Council approval to progress to the final stage of the amendment process by submitting Planning Proposal Amendment 8 to Parliamentary Counsel for an Opinion, then to the Minister of the Department of Planning and Environment for finalisation and notification of the amendment on the legislative website.

# Background

A desk top review of the Wentworth LEP 2011 Schedule 5 Environmental Heritage list identified twenty-one list errors and four mapping errors.

Consultation with Council's former Heritage Advisor also revealed that one commercial building had been erroneously omitted from the list and one dwelling had been renovated and another significantly fire damaged, and their significant heritage features no longer existed.

All of these errors were detailed in the planning proposal report submitted to the Department for consideration of a gateway determination.

# Matters under consideration

The Gateway Determination that was issued by the Department conditioned that Council undertake community consultation for 28 days in accordance with sections 56 (2)(c) and 57 of the Environmental Planning and Assessment Act 1979.

Consultation was conducted for 28 days between 22 July 2016 and 19 August 2016. At the close of the consultation period, Council had received no community submissions to the proposal.

The Gateway Determination also required consultation with the Office of Environment and Heritage (OEH) in accordance with section 56 (2)(d) of the Environmental Planning and Assessment Act 1979.

Council, therefore, notified OEH in writing of the proposal and provided them with 21 days to respond to that notification.

The response to this notification was supplied by the Heritage Council of New South Wales, which raised no objections to the proposal to rectify errors in Schedule 5 or the heritage mapping and supported the inclusion of the additional item to the list.

The response to the removal of two items was to advise Council that the decision to remove these should be on the basis of an assessment of the heritage significance of those items.

# Refer to Attachment 1.

The proposal to remove both of these items from the list and associated mapping is based on an inspection and assessment undertaken by Council's former heritage advisor. The decision to remove both of the items was formed on the advice that one building had been destroyed by fire and the other building had been significantly renovated and modified which had compromised and removed the significant heritage features of that building. Therefore, the advice provided by the Heritage Council NSW has been satisfied.

All conditions of the Gateway Determination dated 2 June 2016 have been satisfactorily completed.

One additional change has been made to Schedule 5 Environmental Heritage list following the advice received from the NSW Heritage Council regarding the level of significance of the Old Wentworth Gaol.

This item, number I50 in Schedule 5 Environmental Heritage list, is now included on the State Heritage Register, therefore the WLEP 2011 heritage list needs to be altered to reflect the Gaol's level of significance.

The site is owned by Crown Lands with Wentworth Shire Council as the Trustee. Therefore, the change to the significance listing will not have any negative impact on the owner or user of the site.

Thank you for your letter dated 11 October, 2016 regarding the abovementioned planning proposal, requesting comments from the Heritage Council.

The planning proposal seeks to:

- · Rectify minor descriptive errors in Schedule 5,
- · Rectify minor mapping errors,
- Inclusion of one (1) heritage item of local significance which was erroneously omitted from the environmental heritage list at the time of the conversion of the new standard instrument, and
- Removal of two (2) heritage items of local significance from Schedule 5 of the LEP, due to loss from fire and extensive renovations.

The Heritage Division raises no objection to the rectification of errors and updating of existing details and descriptions within the Schedule 5 and/or Heritage Maps of the Wentworth LEP 2011. It is considered that the inclusion of an additional item of heritage significance, will assist in providing a link between past, present and future generations and provide statutory protection to assist with conservation and management of significant places. The Heritage Council of NSW supports the listing of items of local heritage significance where they are supported by a robust heritage assessment.

The planning proposal also aims to remove two (2) items from Schedule 5 - Environmental Heritage list and associate mapping. The removal of one of the items is due to severe fire damage that left the dwelling completely gutted including damage to the structural integrity of the internal brick walls as a result of the heat of the fire. It is noted that Development Approval has already been issued for the demolition of the dwelling on the basis of the advice provided by the heritage advisor. The Heritage advisor has recommended the remaining item to be removed because of the modifications made to this dwelling which have compromised most of its heritage values.


