Planning Proposal (PP_2017_MIDWR_001_00) to amend Mid Western Regional Local Environmental Plan 2012 - 25B Dewhurst Drive, Mudgee.

I am writing in response to Council's request for a Gateway determination under Section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the Planning Proposal to amend the Mid Western Regional LEP 2012 by changing the minimum lot size at 25B Dewhurst Drive, Mudgee.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination (Attachment 1).

Council should investigate the minimum lot size in this area having regard to the existing settlement pattern, the servicing and visual sensitivity considerations.

Plan making powers were delegated to Councils by the Minister in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan (Attachment 2).

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 10 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment.

All related files for the LEP Amendment, including PDF Maps, Map Cover Sheet, Planning Proposal document and GIS Data, if available, must be submitted to the Department via the Planning Portal Website at https://www.planningportal.nsw.gov.au/planning-tools/online-submission-planning-data. To submit the data, Council is required to create an account and log in using these details.

A copy of the request should be forwarded to the Department of Planning and environment (westernregion@planning.nsw.gov.au) for administrative purposes.

In accordance with "A guide to the preparation of local environmental plans" attachment 5 – Delegated plan making reporting template (<u>Attachment 3</u>) is enclosed for Council's information. Table 2 of the attachment is to be completed and included in Council's Section 59 submission and forwarded to the westernregion@planning.nsw.gov.au when requiring the planning proposal be finalised.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under Section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning Proposal (Department Ref: PP_2017_MIDWR_001_00): to change minimum lot size at 25B Dewhurst Drive, Mudgee.

I, the Director Regions, Western at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under Section 56(2) of the *Environmental Planning and Assessment Act, 1979* (the Act) that an amendment to the Mid Western Regional Local Environmental Plan (LEP) 2012 to change minimum lot size at 25B Dewhurst Drive, Mudgee should proceed subject to the following conditions:

- 1. Prior to community consultation the planning proposal is to be amended to address section 117 Direction 5.10 Implementation of Regional Plans. This work is to address the final Central West and Orana Regional Plan.
- 2. Community consultation is required under Sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal is classified as low impact as described in *A guide to preparing local environmental plans* (Department of Planning and Environment 2016) and must be made publicly available for a minimum of **14 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in Section 5.5.2 of *A guide to preparing local environmental plans* (Department of Planning and Environment 2016).

No consultation is required with public authorities/organisations under Section 56(2)(d) of the Act

- 3. A public hearing is not required to be held into the matter by any person or body under Section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. Prior to submission of the planning proposal under Section 59 of the Act, the final LEP maps must be prepared and be compliant with the Department's 'Standard Technical Requirements for Spatial Datasets and Maps' 2015
- 5. The timeframe for completing the LEP is to be **9 months** following the date of the Gateway determination.
