**Request for Gateway Determination – Planning Proposal: Sydney Local
Environmental Plan 2012 – 230-238 Sussex Street, Sydney**

The Council of the City of Sydney on 14 September 2015 and the Central Sydney Planning Committee (CSPC) on 10 September 2015 resolved to approve a planning proposal for 230-238 Sussex Street, Sydney for submission to the Minister for Planning with request for a Gateway Determination. The Planning Proposal seeks to amend the height controls for the subject site.

Copies of Council and CSPC resolution and committee reports are enclosed.

The Planning Proposal has been prepared in accordance with Section 55 of the *Environmental Planning and Assessment Act 1979* (the Act) and the Department's guidelines 'A guide to preparing local environmental plans' and 'A guide to preparing planning proposals'.

Please note that Council resolved on the 14 September that the draft amendment to Sydney Development Control Plan 2012 be exhibited concurrently with the Planning Proposal. A copy of this draft amendment is enclosed.

The City requests a Gateway Determination in accordance with Section 56 of the Act and that the Gateway Determination is issued requiring a 28 day exhibition period.

As with previous planning proposals, the City also seeks to exercise the delegation of the Minister of Planning of all his functions under Section 59 of the Act to make the local environmental plan.

The City looks forward to working with you to progress this planning proposal.
