Council consult with the following agencies: State Transit Authority of NSW **Roads and Maritime Services NSW** Sydney Water Corporation **Energy Australia** Transport for NSW Lifetime Care and Support Authority of NSW NSW Department of Family and Community Services (Housing) NSW Department of Education and Communities **NSW Health Department Rail Corporation of NSW** 3. A public hearing be conducted in accordance with section 59 of the Local Government Act 1993. 4. Council is to ensure that supporting information detailed in Appendix 2 of Practice Note 09-003 is placed on exhibition with the planning proposal 5. The timeframe formaking of the LEP is to be 12 months from the date of the Gateway Determination. Development of a new commuter carparking facility at this site is a commitment by the Supporting Reasons NSW Premier and Minsiter for Transport in delivering improved infrastructure facility for train commuters in the Ku-ring-gai area. The planning proposal will assist in the implementation of the Premier's and Minister's undertaking.
