PANEL CONSIDERATION AND DECISION

The Panel considered: the material listed at item 4, and the material presented at meetings and matters observed at site inspections listed at item 5 in Schedule 1.

As the planning proposal authority, the Panel determined to recommend to the Minister that the proposed instrument, as described in Schedule 1, should be deferred, at the request of the applicant, to allow them the opportunity to address certain issues raised in the report.

The Panel adjourned during the meeting to deliberate on the matter and formulate a resolution. The decision was Unanimous.

The Panel heard from community members on a range of issues, including:

In favour

- Something needs to be done lack of market for what is there now
- Whole of precinct approach would be better
- Not confident about flooding study

Against

- Flooding already happening and is a severe problem
- Adequacy of flood studies
- Traffic increasing problems
- Not just local traffic office, factories and 6 childcare centres contribute
- Public transport West Concord station trains full when they arrive
- On and off-street parking
- Cumulative impact of at least 2 other proposals
- Current overdevelopment
- Emergency access
- Site access and egress
- Climate change
- Moreton Bay fig
- Contamination
- Air quality and air circulation
- Diesel emissions from road and trains
- Request the decision is postponed

• Accuracy/currency of some of the studies and documentation

REASONS FOR THE DEFERRAL

- The Panel considers that the applicant should be afforded the opportunity to respond to a number of issues and indeed the deferral is at their request.
- The Panel notes the applicant had requested the matter be put to the Panel as soon as possible.
- The Panel requests the Department of Planning Industry and Environment engages an independent flood expert with the agreement of the applicant, at the applicant's expense, and according to terms of reference approved by the Panel.
- The Applicant to update their traffic study.
- On the conclusion of the work undertaken by the independent expert and the applicants traffic consultant, the Panel will undertake a site inspection prior to considering its recommendation of the matter and requests the Department and the applicant endeavour to resolve as many issues as possible during that process.
- In due course the Panel will hold an additional public meeting to assist the Panel in providing a recommendation to the Department on whether or not the Planning Proposal should proceed for the Department's consideration and its final decision.
