# Report Title:Heritage Review Amendments - Sutherland Shire Local Environmental<br/>Plan 2015 – Housekeeping Amendment 4

#### **EXECUTIVE SUMMARY**

- A review of Council's existing heritage listed items has been carried out in two parts by a consultant Architectural Projects.
- The first part of the review covered foreshore heritage and the outcomes have been incorporated into SSLEP2015.
- The second phase considered built heritage items, trees, landscapes and landforms. The review was not completed in time to be included in SSLEP2015. The recommendations arising from the review should not be included in the plan.

### **REPORT RECOMMENDATION**

That Council incorporate the recommended changes to Schedule 5 Environmental Heritage of Sutherland Shire Local Environmental Plan 2015 into Amendment 4 as detailed in Schedule A of this Report.

#### PURPOSE

This report details the findings of the heritage review and the recommendations made by Council's Heritage Sub-Committee. It is recommended that an amendment to SSLEP2015 be prepared to

incorporate the findings of the heritage review. It is proposed that these amendments will be incorporated into a Planning Proposal which will become SSLEP2015 Amendment 4.

#### BACKGROUND

The Sutherland Shire Heritage Study was conducted by Perumal Murphy Wu and was completed in 1993. The study informed the establishment of a heritage list which has been included through subsequent Local Environmental Plans. However, this was a very early heritage study and the degree of documentation fell short of current standards.

In 2009 State funding was awarded to Council to complete a comprehensive review of this study and the heritage items of the Sutherland Shire. After a call for tenders, Architectural Project PL were selected to carry out this review. The review aimed to provide a more rigorous basis for heritage listed properties to ensure Council has a strong and defendable base on which to properly manage the heritage values of the Shire.

The review of heritage items was split into two stages; the first stage of the review, dealing with Foreshore Heritage, was successfully completed in 2011. The recommendations of this review were incorporated into the Heritage Schedule of SSLEP2015 and are now in effect. The second stage of the review, known as the Sutherland Shire Community Based Heritage Review, considered built heritage items, trees, landscapes and landforms. The project team included Warwick Mayne Wilson, Heritage Landscape Consultants. Overall, the review considered 289 Items listed in the LEP. The final report includes a series of inventory sheets for the items which detail the significance of each item and, where appropriate, the report also recommends amendments to the heritage listings contained in the LEP. Due to the timing of the Stage 2 review, the recommendations could not be included in the new LEP. This report seeks to include the recommended changes within Amendment 4 to SSLEP2015.

#### DISCUSSION

The following summarises the findings of the review:

#### **Built items:**

Overall, the review found that of the 132 built heritage items, only two items were assessed as now being below the threshold for inclusion as a Heritage Item; 1 Sandbar Place, Port Hacking and 44 National Ave, Loftus. The Heritage Sub Committee has proposed the retention of 1 Sandbar Place, Port Hacking suggesting it be further reviewed and that a wall running from the property onto the adjoining park be included in the review. Consequently, this report only recommends that 44 National Ave, Loftus be removed from SSLEP2015 at this time. These items are detailed in Appendix A - Table

1.

Further research and fabric assessment is required to determine the significance of buildings and substantiate any heritage listing for two items, 8 Oaks St, Cronulla and 10 Adelong St, Sutherland. A third item, 105-107 Kangaroo Point Road, Kangaroo Point was inaccessible and therefore not assessed. These items should remain on the list until such a time that further research can be carried out to determine the significance of the items.

The review also highlights two items, 180 Ellesmere Rd, Gymea Bay and 4 Frangipani Pl, Caringbah South, which may have greater significance than previously found. The review suggests these items would benefit from further research into the history of the items. These items are detailed in Appendix A - Table 2.

#### Landscapes

Of the fifty-eight landscapes reviewed, forty-five were found to be above the threshold for inclusion in the LEP. Seven landscaped items were found to be below the threshold for inclusion in the LEP as a Heritage Item and include trees, a garden and storm water canal. These items are detailed in Appendix A - Table 3. A further six landscapes were recommended to be included as part of other listings. These were mainly gardens and grounds of houses where it was considered that a separate listing was unnecessary. These items are detailed in Appendix A - Table 4. The recommendation to the report is consistent with the decision of the Heritage Sub Committee. Heathcote Hall and grounds are recommended to be combined, however this was actioned as part of the preparation of SSLEP2015 and does not need further action.

#### Landforms

Twenty-nine landforms were reviewed by project consultant Warwick Mayne Wilson. Eleven were found to be above the threshold for inclusion in the LEP. Sixteen were found to be below the threshold for heritage listing. Two landforms were not located being; Sandstone Steps and a wishing well in creek bed, both located in Woronora. These items are proposed to be removed.

Of the sixteen items identified in the review for removal, the Heritage Sub Committee has proposed two items be retained being "Swallow Rock" rock formations, east of boat ramp in Grays Point and sandstone caves and wind eroded formations on foreshore in Cronulla. The remaining items to be removed include sandy beaches, mangrove stands and sandstone formations. These items are detailed in Appendix A - Table 5.

#### Trees

Seventy trees were reviewed; of these thirty-one were found to be above the threshold. Thirty-eight trees were found to be lacking in historic values, with aesthetic values typical of any mature planting. These items, therefore, did not meet the threshold for listing within a LEP. The consultant recommends that, unless further evidence is found that associates these plantings with a local historic theme, they should be protected in a significant tree register rather than a LEP. Council does not have a significant tree register; however, the LEP provides protection to most trees unless they can be removed through DCP provisions. Most of these items are also growing on public land and, therefore, less likely to be removed. One item in Lucas Heights; Eucalyptus paniculata (Grey Ironbark) – 2802 (T5), was not accessible and therefore not assessed. It is proposed to remain on the heritage list. The Heritage Sub Committee did not make any specific decision in relation to the tree listing recommendations. A full list of the trees proposed to be removed is attached as Appendix A - Table 6.

#### **Potential Items**

The review also highlighted 19 potential items through the course of the study. There is insufficient information to include these items at present. However, it is recommended that Council undertake a further study to determine their level of significance and whether they should be included in a subsequent amendment to the LEP:

#### Item names and descriptions

The review also proposes a number of generally minor changes to the names and descriptions of the 80 items included in the review. The amendments propose to include features or structures which support the heritage significance of an item, such as a stone fence in conjunction with a house. These are detailed in Appendix A - Table 7.

#### Changes to Heritage Maps

The review also proposes a number of changes to the mapping of heritage items. These changes may extend the area covered by the listing so as to ensure protection of the item, or may reduce the size to clarify the area to be protected. These changes are detailed in Appendix A - Table 8.

#### CONSULTATION

The final report of the Sutherland Shire Community Based Heritage Review was initially considered by Council's Heritage Sub-Committee on 20 November 2013, where further information was requested. The Sub-Committee again considered the review at 17 September 2014 and recommended that a number of items highlighted for removal be maintained on the heritage list (EHR065-15 ). Comments from the minutes of the Sub-Committee meeting in relation to the items proposed to be removed are provided in Appendix A.

#### **BUDGET AND RESOURCES**

The amendments to the heritage list can be undertaken as part of Amendment 4 to Sutherland Shire Local Environmental Plan 2015, resourcing for which forms part of the allocation for Strategic Planning.

Council has sought funding assistance from the Office of Environment and Heritage to carry out a study of the potential heritage items to determine whether they are appropriate for inclusion on the Heritage List. However, funding was not awarded. It is recommended that the investigation of these items remain on the work program of Strategic Planning and further applications be made for funding to help carry out the work.

#### POLICY

The recommendations contained in this report will form part of a Planning Proposal to amend SSLEP2015.

#### CONCLUSION

The completion of the second stage of the Sutherland Shire Community Based Heritage Review has led to a stronger information base to support Council's decisions in relation to heritage items. The Review has led to a series of recommended amendments to the Heritage Schedule of SSLEP2015 discussed throughout this report. These changes ensure the Heritage Schedule is accurate and defendable, providing a clear position for the community and land owners. It is recommended that the changes be included in Amendment 4 to SSLEP2015.
