Planning proposal to amend the Strathfield Local Environmental Plan 2012 – PP_2016_STRATH_001_00 – Housekeeping Amendments

I am writing in response to Council's request for a Gateway determination under Section 56 of the *Environmental Planning and Assessment Act 1979* for the above planning proposal.

As delegate for the Greater Sydney Commission, I have now determined that the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have determined that the planning proposal is inconsistent with Section 117 Directions 1.1 – Business and Industrial Zones and 6.3 – Environmental Protection zones, in respect of Item 1 to apply development controls to the Enfield Intermodal Logistics Centre. This Item is to be removed from the planning proposal. No further approval is required for the other Items.

Plan making powers were delegated to councils in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amended Local Environmental Plan (LEP) is to be finalised within 6 months of the week following the date of the Gateway determination. Council should aim to commence exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to

meet these commitments, the Greater Sydney Commission may take action under s54(2)(d) of the EP&A Act if the timeframes are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2016_STRAT_001_00): minor policy and housekeeping amendments.

- I, Director, Sydney Region East at the Department of Planning and Environment, as delegate of the Greater Sydney Commission, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the *Strathfield Local Environmental Plan 2012* should proceed subject to the following conditions:
- 1. Prior to public exhibition, the planning proposal is to be updated to include a plain English explanation of the intended effect of the proposed provisions.
- 2. Prior to public exhibition, the planning proposal is to be updated to remove Item 1, which seeks to apply height and FSR controls to the southern section of the Enfield Intermodal Logistic Centre site.
- 3. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs* (Department of Planning and Infrastructure 2013).
- 4. Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:
 - Office of Environment and Heritage;

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).

6.	The timeframe for completing the LEP is to be 6 months from the week following
	the date of the Gateway determination.
