#### 1 Name of Plan

This Plan is Strathfield Local Environmental Plan 2012 (Amendment No 9).

#### 2 Commencement

- (g) SP 7275, 415 Liverpool Road, Strathfield,
- (h) Lot 70, DP 1140766, Lot 5, DP 786128 and Lot 234, DP 1017952, 1 and 2–36 Weeroona Road, Strathfield.
