Planning Proposal - Maximum Height of Buildings - Property Nos 2 - 4 Epping Road, Epping

The purpose of this letter is to present a Planning Proposal to increase the Maximum Height of Buildings for property Nos. 2 - 4 Epping Road, Epping, to the Minister to seek a Gateway Determination in accordance with Clause 56 of the *Environmental Planning and Assessment Act, 1979* (EP&A Act).

At its meeting on 11 February 2015, Council considered Group Manager's Report No. PL6/15 (copy attached) concerning a planning anomaly that had arisen from the final Epping Town Centre Urban Activation Precinct Plan and subsequent *State Environmental Planning Policy (Epping Town Centre) 2013* (the SEPP Amendment) amendment of *Hornsby Local Environmental Plan 2013*.

The SEPP Amendment zoned properties No. 2 – 14 Epping Road R4 – High Density Residential. A maximum building height of 17.5m (5 storeys) was applied to property Nos. 2 – 4 Epping Road, however, a 26.5m (8 storeys) height was applied to property Nos. 6 – 14 Epping Road.

Council resolved to progress a Planning Proposal to amend the Height of Buildings Maps of *Hornsby Local Environmental Plan (2013)* to increase the Maximum Height of Building permitted for property Nos. 2 - 4 Epping Road Epping from 17.5m (5 storeys) to (26.5m) 8 storeys.

In accordance with Council's resolution, please find attached a Planning Proposal setting out Council's objectives and intended outcomes, justification for the proposal and the intended community consultation to be carried out. I would be pleased if you would refer it to the LEP Review Panel for a Gateway Determination. Council is also seeking Authorisation to Exercise Delegation for this Planning Proposal.
