Amended Planning Proposal: Amendment 1 of Sutherland Shire's new LEP [In response, please quote File Ref: LP/06/640581]

On 2 May 2014, council submitted a planning proposal to NSW Planning & Environment for a Gateway Determination in accordance with Section 56 of the *Environmental Planning & Assessment Act 1979.* The proposal addresses minor rezoning and reclassification matters that were not included in draft Sutherland Shire Local Environmental Plan 2013 (SSLEP2013). These changes are intended to form Amendment 1of Sutherland Shire's new LEP, once made.

However, in early June it was discovered that council's resolution approving the planning proposal unintentionally omitted an item: the proposed reclassification and rezoning of part of 2R Alexander Avenue, Taren Point. Thus, this matter was omitted from the planning proposal. Planning & Infrastructure was informed of the omission and advised council to submit an amended planning proposal.

At its meeting of 24 June 2014 council resolved, "that the Environmental Planning Unit prepare and submit an amended 'Planning Proposal: Amendment 1 of Sutherland Shire's new LEP' to Planning and Environment to reclassify approximately 75.5m² of land in 2R Alexander Avenue (Part of Lot 1 in DP 234622) from 'Community Land' to 'Operational Land', and rezone the land from RE1 Public Recreation to E4 Environmental Living."

Attached is the amended planning proposal (and supporting appendices) which now considers the following properties:
