Planning proposal: 48 Duxford Street, Paddington

On 16 November 2015 Council resolved to prepare a planning proposal for 48 Duxford Street, Paddington. In summary, the objective of the planning proposal is to include the property in Schedule 5 of Woollahra Local Environmental Plan 2014 as a local heritage item. The Council's resolution stated:

- A. THAT a planning proposal be prepared to list 48 Duxford Street, Paddington as a heritage item in the Woollahra Local Environmental Plan 2014.
- B. THAT when requesting a gateway determination for the planning proposal at point A above, the Council seek delegation of the plan-making steps under section 59 of the *Environmental Planning and Assessment Act 1979*.

The planning proposal (see attached) is submitted for a gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act).

As this matter is of local significance, we also seek delegation of the plan-making steps in section 59 of the Act (see part B above). This delegation will be to the position of General Manager, and sub-delegated to the Director - Planning and Development as set out in the Council's resolution of 26 November 2012. The Department's document titled '*evaluation criteria for the delegation of plan making functions*' is attached to this letter.
