

Gateway Determination

Planning proposal (Department Ref: PP_2016_RYDEC_006_00): to amend the zoning, building height, floor space ratio and lot size controls at 61 Lane Cove Road and 5 Myra Avenue, Ryde.

I, the A/Director, Sydney Region East, at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Ryde Local Environmental Plan (LEP) 2014 should proceed subject to the following conditions:

- 1. Community consultation is required under sections 56(2)(c) and 57 of the Act 1979 as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28** days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Environment 2016).
- 2. Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:
 - Roads and Maritime Services
 - Department of Education and Communities

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. The timeframe for completing the LEP is to be **9 months** following the date of the Gateway determination.



The LEP maps shall be prepared in accordance with the requirements of the 5. Department's "Standard Technical Requirements for Spatial Datasets and Maps" (2015).
