**Sydney Local Environmental Plan 2012 - Planning Proposal
60 Martin Place, Sydney**

The Council of the City of Sydney on 15 September 2014, and the Central Sydney Planning Committee (CSPC) on 11 September 2014, resolved to approve a Planning Proposal for 60 Martin Place (including part of 197 Macquarie Street) for submission to the Minister for Planning with a request for a Gateway Determination under Section 56 of the *Environmental Planning and Assessment Act 1979*. Copies of Council and CSPC resolutions and committee reports are enclosed.

The Planning Proposal has been prepared in accordance with Section 65 of the *Environmental Planning and Assessment Act 1979* (the Act) and the Department of Planning and Infrastructure guides titled 'A guide to preparing local environmental plans' and 'A guide to preparing planning proposals'.

An electronic copy of the Planning Proposal (including appendices) is provided with this submission.

Please note that Council also resolved on 15 September 2014 that a supporting draft amendment to *Sydney Development Control Plan 2012* be exhibited concurrently with the Planning Proposal. This is included for your reference.

The City requests a Gateway Determination on the Planning Proposal in accordance with Section 56 of the Act, and that the Gateway Determination is issued to require a 28 day public exhibition period.

As with previous Planning Proposals, the City also seeks authority to exercise the delegation of the Minister for Planning of all her functions under section 59 of the Act to make the local environmental plan.

The City looks forward to working with you to progress this Planning Proposal.
