Planning proposal to amend draft Sutherland Local Environmental Plan 2015

I am writing in response to your Council's letter dated 19 September 2014 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the planning proposal (dated 18 November 2014), to enable complying development in zone E4 Environmental Living.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

The Minister delegated plan making powers to Councils in October 2012. It is noted that Council intends the plan be made at the same time as the draft Sutherland LEP 2015. Notwithstanding, the Department advised Council that the plan should be considered as an amending plan to the draft, once made. After receiving Council's subsequent request for delegation, I considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending LEP is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2014_SUTHE_003_00): to enable complying development in zone E4 Environmental Living.

I, the Director, Metropolitan Delivery (CBD), at the Department of Planning and Environment, as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* that an amendment to the draft Sutherland Shire LEP 2015, to enable complying development in zone E4 Environmental Living, by amending Schedule 3 of the draft Sutherland Shire LEP 2015 to insert local provisions for dwelling houses and ancillary development, should proceed subject to the following conditions:

- 1. Prior to undertaking public exhibition, the planning proposal is to be revised to:
 - (a) include an assessment against the mandatory and the local zone objectives of the E4 Environmental Living zone; and
 - (b) demonstrate consistency with 'A Plan for Growing Sydney', released on 14 December 2014.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the *Environmental Planning and Assessment Act* 1979 (EP&A Act) as follows:
 - (a) the planning proposal is considered to be routine as described in *A Guide to Preparing LEPs (Department of Planning and Environment 2013)* and must be made publicly available for a minimum of **28 days**;
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning and Environment 2013)*; and
- 3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
