RE: PLANNING PROPOSAL 3/16 – 100 CHRISTIE STREET, ST LEONARDS

Council is seeking a Gateway Determination for Planning Proposal 3/16, which seeks to amend North Sydney Local Environmental Plan 2013 (NSLEP 2013), by amending planning controls as they relate to 100 Christie Street, St Leonards. In particular, the Planning Proposal seeks to:

- increase the maximum building height from 49m to 132m;
- impose a maximum floor space ratio (FSR) of 18:1;
- impose a minimum non-residential FSR of 4.25:1; and
- add a clause to Schedule 1 *Additional Permitted Uses* such that "shop top housing" is permissible with consent on the subject site

The Planning Proposal is also accompanied by a Draft Voluntary Planning Agreement (VPA) which seeks to provide Council with a material public benefit in the form of two floors of commercial office space within the building podium, embellishment and dedication of the Christie Street Reserve to Council in perpetuity, upgrade of Chandos Street and Sergeants Lane and a monetary contribution of \$100,000 to Council for the purpose of a bike hub in the area.

Background

At its meeting on 4 December 2017, Council considered an assessment report in relation to Planning Proposal 3/16 where it resolved to support the Planning Proposal. However, it deferred its recommendation to forward the Planning Proposal to the Minister for Planning in order to receive a Gateway Determination, until a number of issues were resolved with regard to the associated VPA. In particular, Council resolved:

- 1. THAT upon satisfactory negotiation of issues with the draft VPA as identified by Council's lawyers, the General Manager be given the authority to forward the attached Planning Proposal to the Minister for Planning in order to receive a Gateway Determination in accordance with Section 56 of the Environmental Planning and Assessment Act, 1979.
- 2. **THAT** the associated draft Voluntary Planning Agreement, as endorsed by the General Manager as outlined in Recommendation No.1, be exhibited concurrently with the subject Planning Proposal conditioned on it receiving a Gateway Determination.

Following a protracted period of negotiations with the proponent, on 1 May 2018, Council's General Manager endorsed a finalised version of the Draft VPA for public exhibition purposes, enabling the Planning Proposal to be forwarded to Minister for Planning in order to receive a Gateway Determination.

Request

In accordance with its resolution, Council now seeks a Gateway Determination in accordance with Section 3.34 of the Environmental Planning and Assessment Act, 1979 for Planning Proposal 3/16.

Please find attached a CD containing the following:

- Council officer's report including Council's resolution;
- Planning Proposal;
- Draft VPA; and
- Plan making authorisation checklist.

Council and the Applicant have been proactively working in relation to the redevelopment of the subject site for an extended period of time. Whilst it is recognised the work that the Department is undertaking with regard to the St Leonards Planned Precinct, Council does not want to see conditions imposed on the Gateway Determination that may jeopardise the delivery of a significant new building within St Leonards which aligns with Council's Strategic Plan for the locality and will also deliver a substantial piece of community infrastructure. Therefore, to avoid any unnecessary delays in the progression of the Planning Proposal, it is respectfully requested that prior to issuing any Gateway Determination in relation to this Planning Proposal, that the Department contact Council to discuss any potential conditions that may be imposed on the Gateway Determination.

Delegation of Plan Making Functions

Council also respectfully requests authorisation to exercise the functions of the Greater Sydney Commission under Section 3.36 of the Environmental Planning and Assessment Act 1979. A copy of the authorisation checklist has been included on the attached CD.
