Applies when a planning proposal affects land within an existing or proposed business or industrial zone.	Though the proposal may reduce the likelihood of commercial development on the site, if a commercial use is considered viable on this site it is still a permissible land use.	
	The additional permitted use will provide for additional permanent residents to help support the existing businesses in the area that are currently impacted by seasonal fluctuations in local population.	
1.3 Mining, Petroleum Production and Extractive Industries		
Aims to ensure that the future extraction of State or regionally significant reserves of coal, other minerals, petroleum and extractive materials are not compromised by inappropriate development. Applies when a planning proposal would have the effect of prohibiting the mining of coal or other minerals, production of petroleum, or winning or obtaining of extractive materials, or restricting the potential of development resources of coal, other mineral, petroleum or extractive materials which are of State or regional significance by permitting a land use that is likely to be incompatible with such development.	The site is located within an urban area and is unlikely to be suitable for mineral extraction.
