Beach Road Berry Planning Proposal Request for an extension to the Gateway Deadline

I refer to the Gateway determination for Planning Proposal (PP) [PP_2017_SHOAL_001_00] Beach Road Berry dated 6 June 2017. This determination provided a period of 18 months for the completion of the LEP. The purpose of this letter is to seek a revised Gateway determination with a 12-month extension to this timeframe to enable completion of the PP.

The delay for this PP has been caused by the discovery of an Aboriginal Scarred Tree on the property. This tree was recommended for listing as a heritage item in the LEP. However, approximately two weeks ago the tree was struck by lightning and severely damaged. This has led to a need to reassess the tree, which will involve gathering the relevant Aboriginal stakeholder for another site inspection. This will require some time.

The 12-month extension is intended to allow enough time to seek an amended gateway to list the tree as a heritage item in the event that the remains of the tree warrant this.

We have otherwise completed all aspects of the Gateway determination necessary to allow us to commence agency consultation and then publicly exhibit the PP. I have tabulated this below for your assistance:
