#### **PURPOSE**

To provide a response to representations from the Hon Andrew Constance MP, Minister for Ageing and Minister for Disability Services, Member for Bega on behalf of Mr and Mrs Vipond about the proposed zoning of their land at Ridge Road, Coolagolite.

#### RECOMMENDATION

That the Minister signs the attached letter, if approved.

#### **CURRENT POSITION**

- The draft Bega Valley Local Environmental Plan (LEP) 2011 was exhibited until July 8 2011.
- Council is currently reviewing the submissions and is considering potential changes to the draft LEP in response to those submissions.
- The Vipond's land is proposed to be zoned E4 Environmental Living as it contains valuable native vegetation.

#### BACKGROUND

- The Vipond's land is currently zoned 1(c) Small Rural Holdings with a minimum lot size of 5000m<sup>2</sup> for a dwelling.
- The draft LEP zones it E4 Environmental Living with a minimum lot size of 5 ha.
- Bega Valley Council has sought to address an oversupply of rural residential zoned land by limiting the amount of development in locations affected areas of high conservation value vegetation.

I refer to your representations on behalf of Mr W and Mrs N Vipond, concerning the draft Bega Valley Local Environmental Plan 2010 (draft LEP) and its zoning of their land.

I am advised the exhibition of the draft LEP has ended and I note that Mr and Mrs Vipond have made a submission to Bega Valley Shire Council concerning the proposed planning controls for their land.

I understand Council is currently reviewing submissions to the draft LEP and is considering whether changes are necessary in response to those submissions.

I am also advised Council chose the E4 Environmental Living Zone and a 5 hectare minimum lot size for the Viponds' land due to its valuable vegetation that is worthy of protection.

I encourage your constituents to continue their dialogue with Council on this matter. Please note that before any decision is made on the draft LEP, Council is required to give careful consideration to all submissions made. Subsequent to this, the Department of Planning and Infrastructure will review how Council has responded to the submissions received during the public exhibition of the draft LEP.
