REQUEST FOR PLANNING PROPOSAL NOT TO PROCEED PP 2012 GOSFO 007 00

PURPOSE

 To recommend the Executive Director, Regions as delegate of the Minister for Planning agree to alter the Gateway Determination for Planning Proposal PP_2012_GOSFO_007_00 to enable the matter to not proceed and issue an Alteration of Gateway Determination.

RECOMMENDATION

- That the Executive Director, Regions as delegate of the Minister for Planning:
 - agree under s56(7) of the Environmental Planning and Assessment Act 1979
 (the Act) to alter the Gateway Determination for Planning Proposal
 PP_2012_GOSFO_007_00 in accordance with the Alteration of the Gateway
 Determination document (<u>Tab A</u>), which in summary involves:
 - amending the determination to not proceed; and
 - deleting the original determination conditions.
 - o sign the Alteration of Gateway Determination (Tab A); and
 - o sign the letter to Central Coast Council (Tab B).

CURRENT POSITION

- The former Gosford City Council prepared a Planning Proposal to amend the zoning for a site at Mangrove Creek from environmental protection to special purposes (infratsucture).
- The land is currently being used as a 'recreational / education establishment'
 despite being prohibited under the environmental protection zone. The current
 use operates under an existing consent, and rezoning the land would permit
 expansion of this existing facility.
- A Gateway Determination was issued on 17 May 2012 (<u>Tab C</u>) allowing the proposal to proceed subject to conditions.
- The initial Gateway Determination specified was to be finalised by 25 February 2013, being nine months after the Gateway Determination. The timeframe to finalise the Planning Proposal has been extended four times, with a total extension timeframe of 27 months.
- Agency consultation under s56 of the Act has taken place. The proposal has
 unresolved objections from the Rural Fire Service (RFS) (<u>Tab D</u>). The NSW Office
 of Environment and Heritage (OEH) has also raised concerns with the proposal
 and indicated that it does not support the matter progressing as currently
 proposed (<u>Tab E</u>).
- Council has resolved to discontinue the Planning Proposal given the unresolved objection from NSW Rural Fire Service and other matters including inconsistency with Section 117 Directions, risk of life, insufficient information, outstanding issues

from government agencies and inconsistency with Council's plan making delegation. On 9 May 2017, Central Coast Council advised the Department of this resolution (Tab F).

Council's request is considered reasonable as the proposal has been unable to comply with RFS and OEH requirements within the extended timeframe and neither agency supports the proposal.

Alteration of Gateway Determination

Planning Proposal (Department Ref: PP_2012_GOSFO_007_00)

I, the Executive Director, Regions, at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* to alter the Gateway Determination dated 17 May 2012 (as since altered) for the proposed amendment to the Gosford Local Environmental Plan 2014 as follows:

1. Delete:

"I, the Director General, Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to rezone land at Mangrove Creek Road, Mangrove Creek/Greengrove from 7(a) Conservation to Special Use 5 under the Gosford Interim Development Order 122 or SP2 Infrastructure under the draft Gosford LEP should proceed subject to the following conditions:"

and replace with:

"I, the Executive Director, Regions, at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to rezone land at Mangrove Creek/Greengrove should not proceed."

2. Delete Conditions 1 to 14.

Request for Planning Proposal not to proceed - PP_2012_GOSFO_007_00
