**REQUEST FOR A S73A AMENDMENT - NEWCASTLE LOCAL ENVIRONMENTAL PLAN 2012**

Newcastle City council requests an amendment to the Newcastle Local Environmental Plan (LEP) 2012 under Section 73A of the Environmental Planning and Assessment Act 1979. An amendment to Schedule 5 - Environmental heritage is required as a consequence of an item of heritage significance being listed on the State Heritage Register.

The Office of Environment and Heritage has advised that 'AA Company House' at 195 and 195A-197 Denison St, Hamilton has now been listed on the State Heritage Register. 
