REASONS FOR THE DECISION

The Panel considered the revised planning proposal submitted to Council on 3 October 2018 which seeks to amend the Ryde Local Environment Plan (LEP) 2014 to include the site in Schedule 1. The Panel concurs the planning proposal should proceed to Gateway with additional permitted uses to include site specific development standards to:

- allow Seniors Housing;
- increase the maximum height of buildings (HOB) up to RL52 (four storeys) as presented in the applicant's Concept Plan; and
- increase the maximum floor space ratio (FSR) to 1.20:1.

Further, the Panel recommends the site specific Development Control Plan be finalised, in a timely manner, and exhibited with the planning proposal.
