Hi Christina,

Thank you for the opportunity for the City of Ryde to review the exhibited Planning Proposal and the refined scheme submitted by the Ryde-Eastwood Leagues Club. Council's comments are as follows:

Exhibited Planning Proposal

In principle, City of Ryde is supportive of the proposed amendments to the Ryde LEP 2014 in relation to the additional permitted uses, the height of buildings and the overall floor space ratio(FSR). Council also supports the split of FSR across Stages 1 and 2 of the development.

Exhibited concept scheme

Our remaining concerns on the exhibited concept plan are design issues, which will require further refinements to the proposal at the Development Application stage. The issues are:

- 1. Inadequate setback/separation to the adjoining property at No.135 Ryedale Road
- 2. Visual impact of the vehicle access on Terry Road.

These issues have been raised on pages 5 and 6 in City of Ryde's previous submission dated 10 August 2020 (refer to Attachment E of PP-2021-115 on the Planning Portal).

Refined concept scheme

The submission made by Ethos Urban on behalf of the Ryde-Eastwood Leagues Club includes a refined scheme in Appendix A, which takes into account the detailed provisions of the proposed site-specific DCP. Compared to the exhibited scheme, the key difference in the refined scheme is that, at Stage 2, the built form will be split into two buildings with 12m building separation in between, instead of providing one large building serviced by a single core with long common corridors. The refined scheme has also made adjustments to building dimensions, separation and setbacks in some locations.

City of Ryde supports the following changes in the refined scheme:

- The distribution of floor space over two smaller building forms at Stage 2,
- Breaking up the building mass that fronts Ryedale Road, providing better scale transition to the dwelling houses to the north,
- Creating visual relief and allowing views and access into the central landscaped courtyard from Ryedale Road.
- Improving the amenity to the future occupants by creating more numbers of corner units, views to landscaped space and reducing the number of units sharing a lift per floor, and
- Setbacks and building separation are generally acceptable and consistent with Council's UDRP recommendations, except for the side setback to No.135 Ryedale Road (discussed below).

City of Ryde has concerns about the refined scheme as follows. I will give you a call tomorrow morning to walk you through the issues.

- The overall FSR is estimated to be 1.22:1, exceeding the permitted floor space ratio by approximately 172sqm (similar to two 2-bed units).
- Primary vehicle access to basement car park is still not encapsulated within the building form, which does
 not meet the objective of the Draft site-specific DCP. This issue has been raised previously on the exhibited
 scheme. To address this issue, it is expected that a small reduction of the GFA would be required.

Balconies directly look across the site boundary and borrow amenity from No.135 Ryedale Rd; however, this
does not concern any GFA and is resolvable at the DA stage. Should these balconies be deleted, it should
address Council's concern on the setback/separation to No.135 Ryedale Road.

In conclusion, City of Ryde does not have any objection to the exhibited Planning Proposal. The refined scheme provides an improved design outcome and city of Ryde expects the remaining design issues to be resolved by the Applicant at the DA stage. However, Council retains some concerns around the refined scheme provided with the revised planning proposal and requests that these concerns be addressed in the Department's finalisation report.
