RE: Planning Proposal No 5 Sundry Amendments following Council Meeting resolution to initiate the planning proposal.

Council at the Ordinary Meeting on 15 June 2010 considered a report regarding the above planning proposal. Council resolved as follows:

- That Planning Proposal No 5 Sundry Amendments (including the Supplementary amendments to the LEP Heritage Schedule & Mapping for items I16, I48 and I 60) be forwarded to the Department of Planning and Infrastructure LEP Review Panel for Gateway Determination in accordance with relevant provisions of the Environmental Planning and Assessment Act;

 - Item I60 Old Plough Inn Murringo – delete Lot 82 DP 1115993 and insert Lot 9 Sec 2/8 DP 758734;
- Supplementary Amendments to the LEP Heritage Mapping mentioned above are:
 - Map HER_010 relating to Quamby amendment above;
 - Map HER_026 relating to Murringo amendment above.
