Re: Request for Extension of Time to Finalise Planning Proposal to Amend Great Lakes Local Environmental Plan 2014 Coastal Risk Planning Area Maps

Council has prepared and is processing a Planning Proposal to amend the Coastal Risk Planning Area Maps in Great Lakes Local Environmental Plan 2014.

The Planning Proposal has been progressed in accordance with the Gateway Determination of the Department of Planning and Environment issued on 11 July 2014.

On 13 March 2015 the Department granted an extension of time to the Gateway Determination until 18 January 2016. On 29 January 2016 the Department granted a second extension of time until 18 January 2017. A copy of the original Determination and extensions are attached.

Council requests that the Department grant a third extension of time to allow for the following:

1. The elected Council has requested that no further action on the Planning Proposal be taken until such time as the Minister for the Environment has certified the Draft Great Lakes Coastal Zone Management Plan and Draft Jimmy's Beach Coastal Zone Management Plan.

The Jimmy's Beach Coastal Zone Management Plan has been certified and published in the NSW Government Gazette.

The Great Lakes Coastal Zone Management Plan has been amended in accordance with the NSW Coastal Panel and Minister's requirements but has not yet been certified or published in the NSW Government Gazette.

2. The Minister for Planning announced the Coastal Reforms on 13 November 2015 and the implications for the existing coastal zone management plan projects and the Planning Proposal were somewhat unclear at that time.

3. The Minister subsequently placed the Coastal Management SEPP, S117 Ministerial Direction and associated documents on exhibition on 11 November 2016 and the implications of these reforms are currently being determined.

Great Lakes Council was amalgamated with the former Greater Taree and Gloucester Councils on 12 May 2016.

The former Great Lakes and Greater Taree Council's had different policies and approaches to coastal hazard identification, notification, management and assessment.

Council officers are therefore reviewing the Coastal Reform documentation and will as part of this process, be required to formulate a submission on the basis of a new MidCoast Council approach to coastal hazard identification, notification, management and assessment.

In this regard, the new implementation timeframes, coastal vulnerability area mapping within the State Environmental Planning Policy and parameters of the new S117 Direction in particular, may influence how MidCoast Council progress the Planning Proposal.

Therefore, while a draft submission on the coastal reforms is required to be lodged with the Department of Planning & Environment by 20 January 2017, Council's formal submission, new policy position and therefore resolution of the subject Planning Proposal, cannot be confirmed until a report is tabled at the first available Council meeting in February 2017.

Therefore, on this basis and in view of the ongoing uncertainty associated with the Coastal Reform process, Council requests an extension to the Gateway Determination for the Planning Proposal to amend Coastal Risk Planning Area maps in Great Lakes Local Environmental Plan 2014 until December 2017.

An amended Project Timeline is provided with this request. The request and timeline assume that the Planning Proposal will continue through to completion in a manner consistent with the Coastal Reform framework currently on exhibition.

Upon confirmation of the extension, the Project Timeline will be incorporated into the Planning Proposal in accordance with the Gateway Determination.
