Planning proposal no. PP_2014_SHOAL_004_00 – Alteration of Gateway determination

Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2014_SHOAL_004_01): to rezone land in the Culburra Beach, Callala Bay and Currarong localities for the purposes of residential, commercial, industrial, recreation and environmental purposes.

I, the Acting Deputy Secretary, Planning Services at the Department of Planning and Environment, as delegate of the Minister for Planning, have determined under section 3.34(7) of the *Environmental Planning and Assessment Act 1979* to alter the Gateway determination dated 16 November 2015 for the proposed amendment to the Shoalhaven Local Environmental Plan 2014 as follows:

1. Change the description of the planning proposal in the Gateway determination:

from "to rezone land in the Culburra Beach, Callala Bay and Currarong localities for the purposes of residential, commercial, industrial, recreation and environmental purposes"

to "to rezone land in the Culburra Beach locality for the purposes of residential, commercial, industrial, recreation and environmental purposes".

2. Delete:

"condition 2(k)(III)" and replace with:

new condition 2(k)(III) "housing supply and demand at Culburra Beach; and"

3. Delete:

"condition 11"

and replace with:

a new condition 11 "The time frame for completing the LEP is by 23 February 2021."
