DESCRIPTION OF LAND: The site is situated on the lower slopes of the Illawarra Escarpment and has a total area of 26.66 hectares. There is a portion of cleared area in the south-eastern portion of the site which measures approximately 1 hectare in area. There is an existing dwelling house upon the site and the site has been used for grazing and cattle farming. The site is made up of cleared grasslands and remnant trees with a well-managed (mostly cleared) understory. Portions of the site are densely vegetated and Endangered Ecological Communities are located on the site (a pocket of subtropical rainforest in the south and a pocket of grassy woodland in the north-east) according to Council's records. Four riparian corridors run across the site.

Surrounding development consists of Wongawilli Colliery to the north and north-east, escarpment lands to the west and rural properties and the West Dapto Urban Release area to the east. Access to the site is currently off Bong Bong Road over an existing right of carriageway shared over the adjacent NRE Wongawilli Colliery land.

The proposed use could be designed so as to fit with the aims and intentions of the strategy The Illawarra Escarpment Land Use Review Strategy (IELURS) 2007 also applies to the site. The proposed use could be consistent with the strategy. Detaild design and assessment would be undertaken at development application stage.
6. Is the planning proposal consistent with applicable state environmental planning policies?	Yes
7. Is the planning proposal consistent with applicable Ministerial Directions (s.117 directions)?	Yes, the proposal is consistent with Ministerial directions 2.1 (Environmental Protection Zones), 3.6 (Shooting Ranges) and 4.4 (Planning for Bushfire Protection). The relocation of the old clay target shooting range is necessary due to the rezoning of the West Dapto urban release area.
