I, General Manager, Hunter and Central Coast Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 ("EP&A Act")* to alter the Gateway determination dated 1 August 2012 (as since altered) for the proposed amendment to the Port Stephens Local Environmental Plan (LEP)(Kings Hill, North Raymond Terrace) 2010 as follows:

  - "insert an eco-tourist facilities clause"

"condition 5"

and replace with:

a new condition 5 "The timeframe for completing the LEP is by 8 February 2015"
