Planning Proposal PP_2012_COOMA_002_00 – Gateway Determination Extension No.2

I refer to your request on 16 August 2013 seeking an extension of time to complete the Planning Proposal PP_2012_COOMA_002_00 to rezone Lot 30, DP 754889, Burra Road, Burra to R5 Large Lot Residential.

I have determined as the delegate of the Minister for Planning and Infrastructure, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to amend the Gateway Determination dated 12/04/2012 and revised on 11/12/2012 for PP_2012_COOMA_002_00.

The Gateway Determination is amended by extending the time for the completion of the Planning Proposal by an additional 9 months. The Planning Proposal is now due for completion by 19 January 2014.

Council should aim to commence the exhibition of the Planning Proposal within four weeks from the week following this revised determination. Council's request for the Department to draft and finalise the LEP should be made six weeks prior to the projected publication date.
